Letter no. C-11011/10/2020-NACO (TI) receive from Sri. Alok Saxena Joint Secretary NACO dated 19/10/2020 regarding Hon'ble Supreme Court judgement dated 29<sup>th</sup> September, 2020 in the matter of Criminal Appeal No (s) 135/2010 has directed all State/UTs to provide dry ration & financial assistance to Sex Workers who are identified by NACO.

The relevant extracts from the order of Hon'ble apex Court is given "Starving Sex Workers are entitled to be provided with dry rations that are identified by NACO without insisting on proof of identity" in this regards NACO has developed Standard Operating Procedures SOP for facilitating identification & linkage of Sex Workers by SACS/ NGOs/CBOs/to avail the facilities of dry ration & financial Assistance being provided through respective State Government.

- 1) As per SOP SACS to be prepare the matrix of district wise SW TI NGO/CBOs under NACP & there contact details & upload the same on official SACS web portal. List is attached for approval
- 2) As per SOP SACS to organize the meeting with SW TI NGO/CBOs for disseminate the details of SOP.
- 3) SACS to form a committee under the chairmanship of PD/APD, AD -TI, AD -IEC, AD- M&S, TSU & Representative from Sex workers will monitor the activities & report to NACO.
